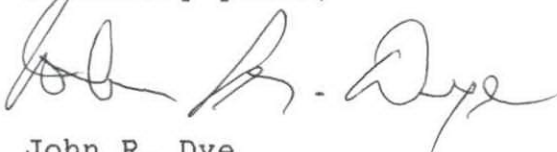

Cap Weinberger deserves pardon in Irangate mess

WASHINGTON — At some point within the next few weeks, George Bush should take a fresh look at a part of the Constitution he seldom has occasion to read. It says of a president: "He shall have power to grant reprieves and pardons for offenses against the United States."

So reminded, Bush should grant unconditional pardons to every person ever harassed by Congress and the "independent counsel" over the events that came to be known as Irangate.

He ought to begin by pardoning Caspar Weinberger.

The story goes back to 1985. In an effort to win release of U.S. citizens held hostage, President Reagan in effect authorized the payment of ransom to Iran. The ransom was to be paid in anti-tank missiles transhipped from Israel.

The rap on Weinberger is that he committed perjury in answering questions, under oath, put to him by the staff of a House committee. He was asked about meetings he had attended at which the deal was discussed. Specifically, he was asked:

Q: Is there any way that you have of making a record of the highlights of meetings of this nature?

A: No. There wasn't.

Q: Do you ever take notes that are not dictated or make jottings when you get back?

A: Yes, occasionally, but comparatively rarely... My handwriting is notoriously bad. I have trouble even reading it myself. Occasionally I take a few notes, but not really very often.

The indictment alleges that Weinberger was an inveterate notetaker. Weinberger's answers may not have been "false, fictitious and fraudulent" as a matter of law; they may not have shown contempt of Congress beyond a reasonable doubt, but they were certainly less than the whole truth.

The question arises: What useful public purpose could be served by subjecting Cap Weinberger to trial? Prosecution would serve only one purpose, and that is to stroke the vanity of Lawrence Walsh, the independent counsel. Walsh's latest stunt was to obtain a fresh indictment of Weinberger before the election.

Now Walsh has retained a San Francisco lawyer, James Brosnahan, to serve as special persecutor of Weinberger. Brosnahan is a Democratic activist.

Pardon Weinberger? Of course the victims of Walsh's vendetta should be pardoned!

Dear Mr. Comer:

Thank you for your letter 9/19/92 in response to my letter 7/7/92 to President Bush regarding the issuance of a patent that acts to impede investment in the development of commerce.

You note, "under the patent laws, there is a presumption of validity to every patent that is granted by the PTO".

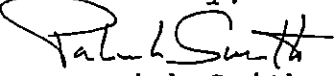
Also, under the patent laws, there is a specification that the subject matter must be "useful". The term "useful" in this connection refers to the condition that the subject matter has a useful purpose and also includes operativeness, that is, a machine that would not operate to perform the intended purpose would not be useful, and therefore would not be granted a patent.

The patent in question, #3,534,676 was improperly issued. The operation of the subject matter (microwave vending machine) was intentionally misrepresented, further, the drawing that shows as a primary element of the machine an oven devise that is described as "a commonly available microwave oven" is false. No such microwave oven exists. No such microwave oven could be made (re. radiation hazard).

This obvious misrepresentation should be apparent to the Patent Office, however, your letter implies that the responsibility to correct this mistake is mine (re. new & useful vending machine). I respectfully submit that your references to policies and procedures and the delay, needless withholding of 100s of jobs in the manufacturing industry is a direct contradiction of the PTO slogan, 75 Years Stimulating America's Progress.

Please inform me of your intention (re. mutual concern) regarding the resolution of this impediment to the development of commerce.

Dear Mr. President:

I am writing to you because I know you are also concerned with this subject. It would be presumptuous of me to impose upon your time and involvement with the affairs of government if it were not for the fact that this subject matter directly relates to the domestic economy, re. the creation of jobs.

I have devised, after years of research, a new and useful vending machine that upon deposit of one dollar transfers a packaged hamburger from the refrigerator compartment to a microwave oven, then cooks and dispenses the hamburger to the patron. An improvement over cold vendors & separate oven.

Additionally, the placement of these vending machines in office buildings, factories, service stations, etc. locations across the country will require a new food service industry necessary to maintain the vendors inventory, thereby creating new jobs nationwide.

However, these new jobs and benefit to the economy are in doubt due to an impediment caused by the Government. An invalid patent was improperly issued by the Patent Office on an inoperable non-useful vending machine that acts to impede the patent application and production of this vending machine, (information and documentation enclosed herewith)

What I respectfully request on the basis of mutual interest is a review of prior action by The U.S. Patent And Trademark Office.

I am writing to you on the advice of Sharon Lias. Her husband, Tom, was my cousin. Sharon suggested you might be willing to help on a serious family matter.

My husband, Hung Lu, was a Vietnamese refugee who fled his homeland in 1975 for the freedom of the United States. A naturalized citizen, he is employed by Digital Equipment Corporation as a Senior Field Service Technician. He has a strong work ethic and believes that you make your own way in this world - not relying on handouts from anyone. (I should also add that he supported both former President Ronald Reagan and President Bush.)

Meanwhile, his family in Vietnam were surviving - but barely. My mother-in-law and her entire family were very well connected with the former South Vietnamese Government. My father-in-law was a major in the South Vietnamese army; he died in 1962 fighting for freedom. After the escalation of the war in the 1960's, my mother-in-law allowed the Americans to use the family home as a command post from 1965 through 1972. When the Communists came into power in 1975, their vengeance was swift and sure. The family home was confiscated, a son was beaten to death in front of his mother and family, and the family was turned onto the streets of Saigon. In 1984, my brother-in-law, Quyen Ding Lu, was "caught" and charged with being on the streets of Saigon without the proper papers. The punishment - a sentence to the re-education camps. He was detained from March, 1984 through June, 1987; when my mother-in-law arranged for his "escape". He then began a "shadow" life in Vietnam, living on the streets, unable to work, unable to pursue an education.

As my mother-in-law was hoping to seek refuge with us here in the States through the ODP program, she became concerned they would be able to trace Quyen via ODP and force him back to the re-education camps. She arranged for him to flee Vietnam in 1990 - he is currently in the Sikew camp in Thailand with his wife and his 6-month old son. His case was originally reviewed by the Thai government in June, 1992 - and they denied refugee status. We have filed an appeal with the UNHCR and have received much help from Ambassador Lafontaine's office.

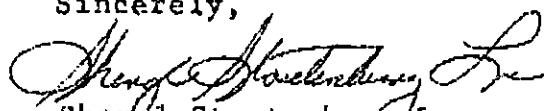
Mr. Baker, we received a letter dated November 4, 1992; from Quyen. He told us that they are currently receiving an allotment of 3 kilograms of rice per week - to support and feed two adults and a child! The baby is ill from malnutrition and the generally poor conditions of the camp. I am aware of the agreements that the U.S. has signed concerning the Vietnamese refugees, however, I am asking you to lend your assistance and save Quyen, his wife and son. The UNHCR will hear their appeal in the first half of 1993, but I'm afraid that little boy does not have the extra time it may take.

We have previously contacted President Bush on this case. And I must say we appreciate the able assistance we received from Nancy Leas-Thompson, Jim Williard, Joseph Coleman and Chick Warner. Senator Paul Simon has also lent his support; as has Dorothy Ivey and her staff at the UNHCR-Washington. However, because of the urgency of the health status of of the baby, I am looking to you to help bring this matter to a speedy end. I should add, that we will accept full financial support and responsibility for all three individuals - as we have noted in all of our communications about Quyen.

We are most appreciative of all your efforts on behalf of our nation, both here at home and throughout the world. We look forward to supporting you in the future; and wish the best for President Bush and his family.

President Bush once indicated, that if there were ever anything he could do to help Tom's family - he would - I am asking now that if possible, he lend us his help.

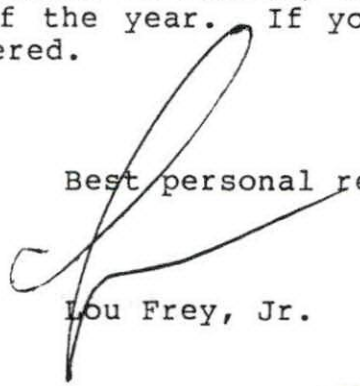
Dear Henson:

CARTER V. CLINTON
LOU FREY, JR., MEMBER OF CONGRESS, FL '69-'79

Governor Bill Clinton told the American people that change is needed and change is what the American people will receive under President Clinton. I was one of the few members of Congress from Florida who served in the minority while President Carter was in office. There will be major differences between the Carter years and the Clinton years to come. Even though the Democrats controlled the House, the Senate and the White House in 1977, checks and balances existed within the Congress. There were a number of Democrat Congressmen, especially from the southeast and southwest who were conservative to moderate in philosophy. They would band together with the Republicans to block bad legislation or at least modify some of the worst provisions of bills proposed by President Carter. Gridlock is not bad when it prevents poor legislation. Once legislation is passed, it is extremely difficult to get off the books.

The situation we face today has its roots in 1974 when the so-called "Watergate Babies" were elected to the House. This large freshman class dramatically changed the House ensuring the more liberal members control the Democrat caucus. Today many of the "Watergate Babies" are in key leadership positions in the House and some have been elected to the Senate. I want to emphasize that in no way are these bad people. Most of them are effective, principled and dedicated members of Congress.

Although the Republicans picked up eight seats in the House, they are still a distinct minority. Furthermore, there is no significant change in the Senate in numbers. The Republicans in the Senate retained the ability to filibuster by two votes, but little more. The Senate will be more liberal in 1993 and the addition of five women will also have an impact.

Governor Clinton has made commitments on numerous legislative issues ranging from universal health care to an increase in taxes on the "rich." Even if Governor Clinton wants to modify his positions and become more of a centerist, as most Presidents tend to do, there is no turning back. The Democrat majority in Congress wants and believes in the legislation he has proposed. The bottom line is no check and balance exists in the legislative branch to stop his proposals.

In the first six months of the Clinton presidency we will see more major legislation passed than in the last twelve years. It is clear that the American public voted for change in 1992. It is clear they are going to get what they asked for, and quickly. What is not clear is if change will be for the better or worse. It is my opinion that change will be the key issue in 1996, but this time it will benefit the Republican nominee.

Please be assured THAT IS NOT for many of your countrymen, including myself!

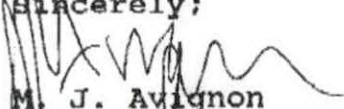

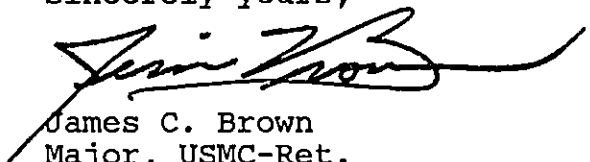
Dear Mr. Baker:

Ten years ago, the Vietnam Veterans Memorial was constructed amidst controversy and anguish. But in the course of that decade, it has become a symbol of reconciliation, not division; of a reborn national will, not to forget, but to forgive and remember. The austere simplicity of the roll call on that Wall tells the story of individual American sacrifice--an indisputable sacred memory of those who paid the highest price for freedom.

The Wall is barely visible from the upper floors of the State Department, yet it can never be far from the gaze of our diplomats. As Secretary of State, it reminded me that the American people are willing to sacrifice, but their government has the duty to weigh its choices carefully and consider the consequences before risking

American lives. This is, and must be, the firm conviction of every post-Vietnam War generation.

While the Wall still stands, another wall, the Berlin Wall, has fallen. There is new hope for a better world. And the Vietnam Veterans Wall should symbolize not the division among us, but the strength of our reconciliation and unity. Those on the Wall, those heroes cast in bronze, would accept no less.

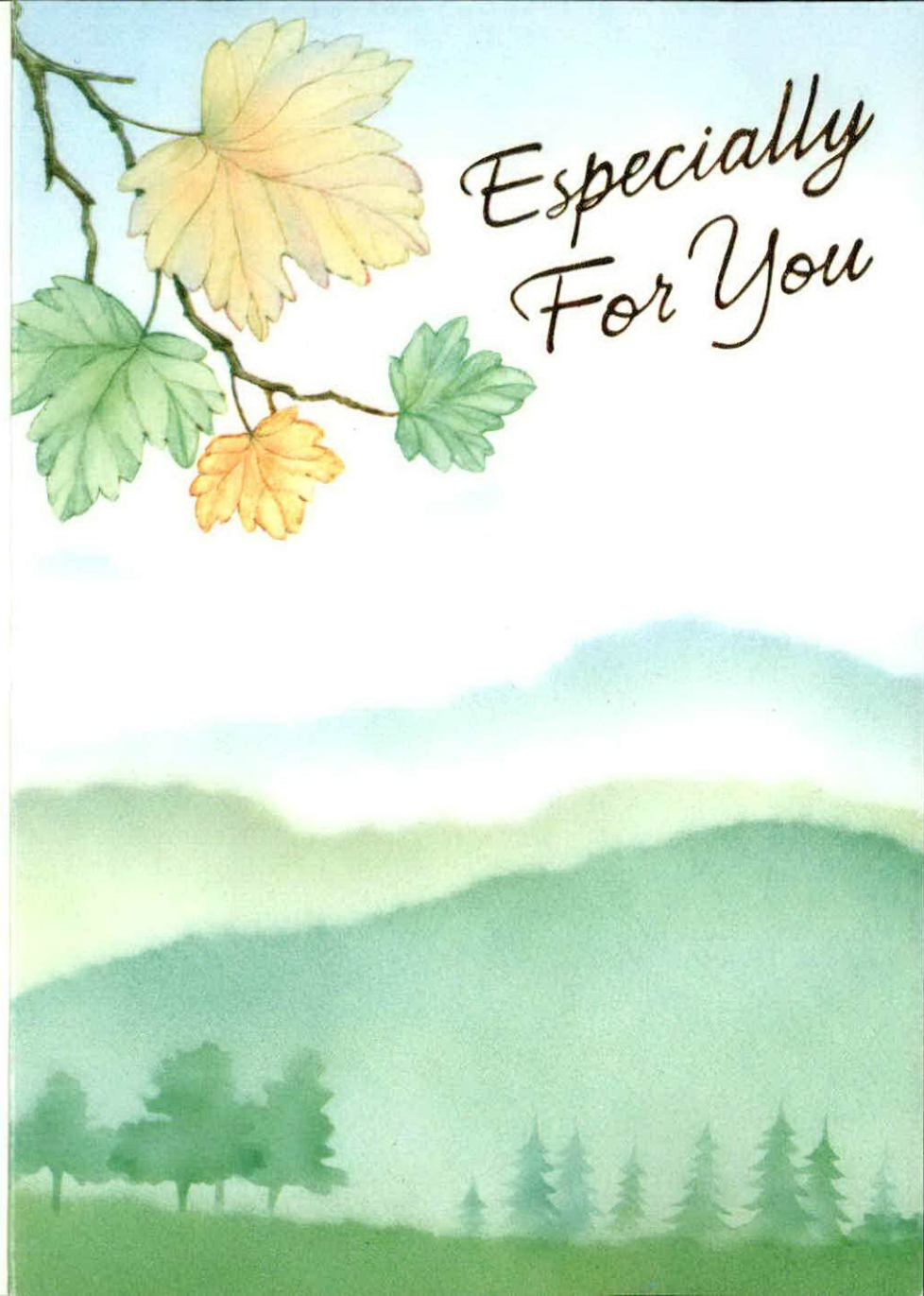

JESUS IS THE WAY

Dear Pastor Paul:

From approximately 1963 to 1980, I collected records. The collection included Rock and Roll to Pop Rock, and all selections in the top 100. Some of the artists included Short Shorts, by the Pony Tails, 1958; Great Balls of Fire, by Jerry Lee Lewis; all the way to Michael Jackson's Greatest Hits of the 80's. This collection included thousands of artists and over twelve thousand (12,000) individual top hits contained in over thirteen (1,300) 45's and over one thousand (1,000) albums. I had double of most records, one of which I would use to play, and the second record would be cleaned, put into static free envelopes, and stored and logged in metal cabinets. Some of the records were out of print, many were collectors, and all were in mint condition.

Back then, if you wanted to find me, most of the time I would be on a dance floor, in a disco, on a racquet ball court, or on water skies; but mostly in a disco because I loved music and I loved to dance. At work, I was known as "The Animal" and "Disco Freak". My favorite dance style was the Latin Imperial. At this time I knew Jesus Christ in my heart, but I was not dedicated to follow him.

In 1983, I purchased a very expensive stereo system valued at four thousand dollars (\$4,000.00). I had it hooked up for approximately three months, but due to circumstances in my life, I had to put the stereo equipment in storage. To date, I have not used it again. Because of a great disaster in my finances over the last seven years, I have been and currently am living in a one room basement apartment, therefore I have not had the room to set up the stereo equipment.

Several years ago, I over-whelmingly dedicated my life to Jesus. My heart and soul was crushed because of circumstances happening in my life. I was in a financial ruin and in a deep state of depression, but my desires were being changed from my desires to God's desires a step at a time.

During this time I had no desire to dance, play racquet ball, or to water ski. My only desire was to learn about the desires and ways of Jesus.

A Christian friend came to me at work one day and said, "Rich, the Lord said to destroy all of your records." I couldn't believe what I had just heard, I pondered for weeks. I thought this couldn't be from God. I had over fifteen thousand dollars (\$15,000.00) invested in this record collection alone, not including the value

of them, but most of all I cherished the music. Several times over the next three months I went through the records and separated just the very special ones, these alone amounted to over one hundred albums (100) and over two hundred (200) 45's. I thought at that time, "God, I'm already in a financial ruin loosing all my possessions except for my record collection and my stereo equipment, and now you want my records too?"

To understand what I mean by financial ruin, I had talked my parents, my uncle, and two very close friends into investing with me in a real estate development. Over a period of time, because we were blinded and deceived, we lost over six hundred thousand dollars (\$600,000.00) in cash, over thirty (30) properties, which left all of us bankrupt. I myself lost everything except my records and stereo equipment, my life and Jesus Christ. At this time I was not able to make a definite decision about what to do about the record collection.

Approximately two months later a lady came into my life who ministered to me and anointed me as an Apostle. Before and during this time I had received visions in my spirit of small groups of people holding hands and

standing in circles singing songs. As they would sing these songs, the atmosphere above them would be consuming fire. Many groups of people would be in this vision singing His songs and the atmosphere would be completely engulfed in fire. During this time, Jesus also led me to several songs of worship by different artists, and led me to Revelation 14 about His New Song.

Though the guidance of the Holy Spirit I was led to splice these songs on a cassette tape and name them His Intimate Songs, and give them to hearts around me as a gift from Jesus.

The lady that God had brought into my life had also prophesied to me, "You have a great collection of records and the Lord has told me to tell you to destroy your records." Well, believe me I was upset again especially because I had never told her about my collection and because I knew God was talking to me in my spirit. Again, I pondered on this decision because I was reluctant to give up something that I really treasured. However, as I started talking to Jesus about the way I felt, His Spirit started helping me to understand that I wasn't giving up anything, but was being prepared to receive more. I knew in my heart that I had a greater desire for God's perfect will and maximum purpose above all things. As I was talking things out with Jesus one

night at work, I decided the records had to be destroyed so that I could keep growing in the Lord. I didn't wait until I got off work, but immediately took off work and went home, got some trash cans together, and started smashing records and covers. As I was doing this, tears flooded my eyes and after five hours I had completely filled up two dumpsters in the alley. I had such a heavy burden lift off my heart at this time because I decided to act in obedience to God.

Several months later my circumstances got worse. My family and friends turned away from me, and the stress and depression began to overtake my soul. During this time I had an unexpected encounter with Jesus Christ at the men's breakfast at Life Christian Center with guest speaker, Jack Harris, (as explained in my Testimony Tape that was given to you). I didn't know it at the time, but this glimpse of Jesus is what brought me through a massive heart attack and a complete nervous breakdown. When we seek for Jesus, we will find Him in unexpected ways. Through all of these circumstances, to the best of my ability, I never stopped seeking, learning, and sharing His truth.

Three months ago I moved my stereo equipment and a few possessions to my parent's house for safe keeping. As I finished unloading everything and was getting back.

into my car, God had put into my spirit that He had plans for my equipment.

Paster Paul, on Sunday, September 16, 1990, as you started sharing about the Church in Brazil that had poor sound equipment, horns on the back wall, outdated 1950 equipment, the anointing of God came on my spirit and a I knew in my spirit that this was the plan that God wanted to use my equipment for. As you called us forward, the Lord quickened in my heart the same words that He told me at work, "Rich, you are not giving anything up, but I am preparing you to receive more". I know in my spirit that many people will be blessed by the sound of this equipment because it is a gift from God.

Hopefully, I pray that this gift will encourage and inspire other hearts to seek and follow Jesus.

Pastor Paul, up until now I could not explain clearly to you how I was able to discern the truth from the false, the insight of God's perfect will, and the hidden motive of man's heart at both Life Christian Center and Abundant Life, but because I seek for the truth, Jesus has led me to John 17:

To those who seek the desires and ways of Christ, (God's perfect will and purpose), will have an encounter with Christ and the Holy Spirit (God's Holy Spirit) will discern through your spirit the perfect insight of God's will and the hidden motive of man's heart, false doctrine, from the doctrine of Jesus Christ.

This is the belt of truth which is a decisive discernment.

Only as we give ourselves to others through the compelling love of Christ, can we yield in obedience to God's spirit and Discerne the Truth From the False.

Hopefully we can meet soon in a comfortable atmosphere to talk.

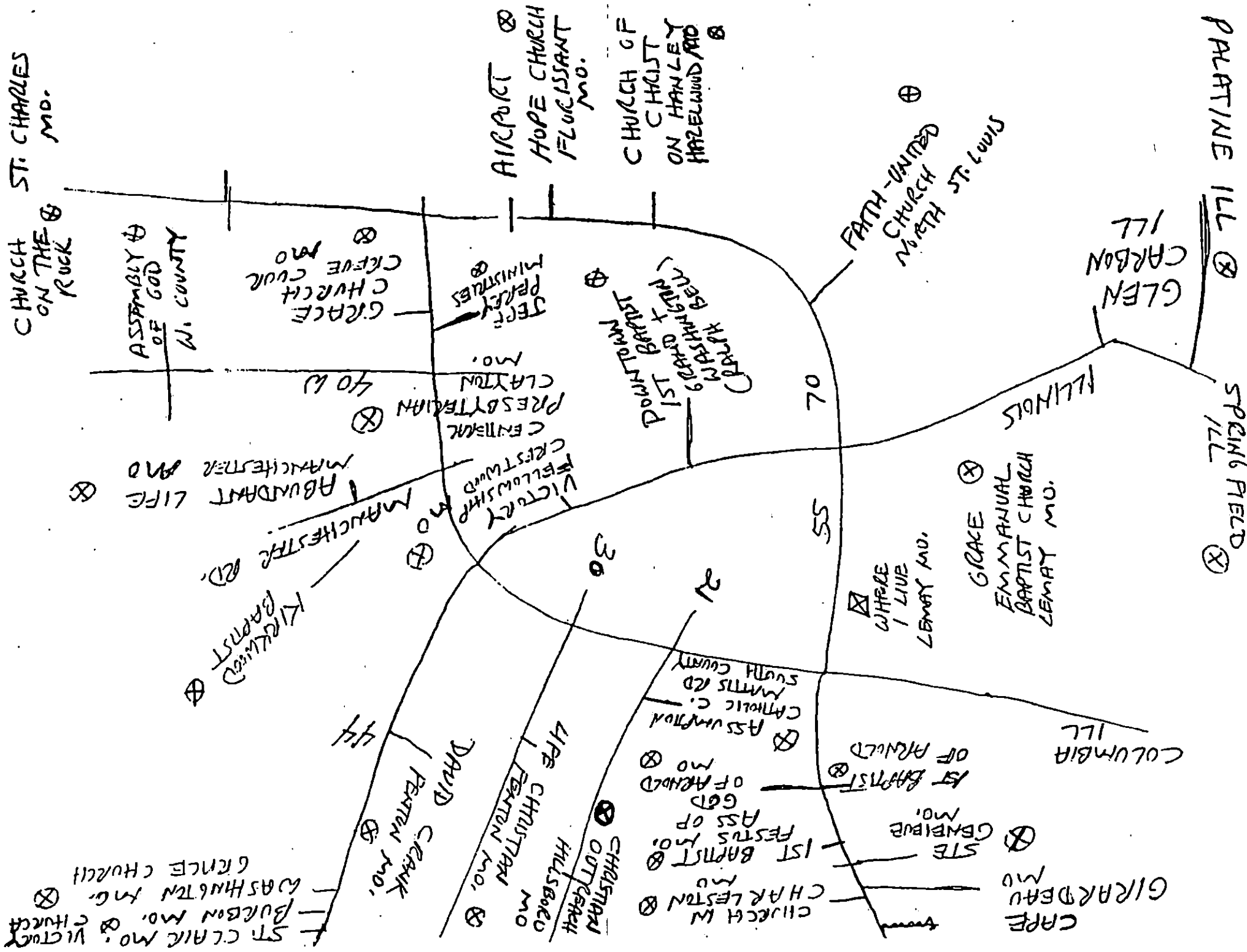

In 1988 while at Life Christian Center, during a worship service, I received a strong-deep vision in my spirit. As my spirit began to weep, the vision grew stronger.

This same vision came into my spirit several times over a period of several months, only during the worship time.

I asked God several times to please explain the fullest of this vision to me clearly.

Several weeks later, the Lord led me to write two outlines: 1. "The Controlling Spirits of Witchcraft In These Last Days", and 2. "If I Do Not Know You, Depart!"

Shortly after I received these visions, I was led by the Lord to two songs, All-Consuming Fire and Hear My Cry, and He also led me to read Revelation 14 about His New Song sung by the 144,000 marked Saints by the Lord of Host.

The Holy Spirit led me to start sharing the printed outlines and songs on a cassette with hearts around me through the leading of God's Holy Spirit.

Over the seven years, God's Holy Spirit led me to put over 19 different songs on cassettes and call them His Intimate Songs, and led me to write over 45 different printed outlines and letters, to share with over 2,000 different people.

The Characteristics of Witchcraft and the Deception in the Body of Christ is the latest outlines.

Through the Knowledge and Understanding of God's Holy Spirit, the vision is "The Last Day Revival of God's Holy Spirit" to purify his church for the second return of God's son, Jesus Christ.

The Fire in the Vision is the Reproof and Purification of God's Holy Spirit.

As we sing His Intimate Songs to each other, a burning desire is started in each heart, and as the atmosphere of the heart is changed to the (Desires of Christ), we will be compelled to seek and do the perfect will of God the Father. (The Ways of God)

You Can't Outgive God

THE OTHER DAY, I received an envelope that held twenty \$1 bills. Along with the money there was a note from a Director asking me to autograph each bill so that she could award them to her Consultants. This happens frequently, and I always write the same thing beside my name: "Matthew 25:14-30." That, of course, is the parable of the talents. I really believe that we are meant to use and increase whatever God has given us. The scripture tells us that when we do, we shall be given more. That truth has been dramatically illustrated throughout my life, but I'd like to tell you about one very special example.

A few years ago, the pastor of my church asked me to address the congregation about raising funds for a children's learning center. I must admit that my first reaction was a sigh. (Well concealed, I hope.) The fund raising effort had been going very slowly. Each Sunday, a member of the congregation had made a plea for the special collection, but the results were still discouraging. No matter who spoke, we just couldn't top \$600 to \$1,000 a week; at that rate, we would not have that building for a long, long time.

With all of this in mind, I felt a little hesitant about accepting the responsibility for an additional Sunday morning speech. Furthermore, I hadn't been involved in the Sunday

school program. So I said to the pastor, "But I don't have anything to do with the children's work in our church. Why not ask someone who works in that area?"

"You do believe children should be brought up in the church?"

"Well, of course I do."

"Then say so."

He had me. "When?" I asked.

"How about six weeks from today?"

The pastor was wise. I'm sure he knew that people will agree to anything that's six weeks away. I decided that I couldn't do much worse than anyone else had done, so I agreed to give it a try.

"I'll do it," I said.

The six weeks seemed to fly by rapidly since I was very busy at the office and had some traveling commitments as well. But, in the back of my mind, I was always searching for the right words to include in my plea to the congregation. It bothered me that I hadn't already written my speech, because I usually plan such work far in advance.

Mel and I were in Chicago the week before I was to address the congregation and, once again, I had been unable to find time to simply sit down and write. On the night before my speech, we arrived home well after midnight. I was very worried because the right words still wouldn't come, but I convinced myself that it would be better to get a good night's sleep and plan my speech in the morning.

That morning Mel and I overslept! When I awoke and looked at the clock, it was after ten. I had less than an hour to get my thoughts in order and be at the church! It takes me longer than that to get dressed every morning. *When* was I going to write my speech? I had fully intended to have some quiet time that morning to work up the best presentation I could. And look what had happened! For about five seconds,

I thought longingly of just staying home. But that was impossible, I had to keep my promise.

Mel was already racing around getting ready, and so I did the same. I grabbed the first dress I saw in my closet, and as I was slipping it on, I thought, "Lord, fill my mouth with worthwhile words, and stop me when I've said enough." Obviously the speech was going to be in His hands, for I didn't even have time to think!

"You'll have to tell me what to say, Lord," I prayed. And then I stopped dead in the middle of putting on my make-up, because a thought had come to me so clearly and suddenly that I was shocked: "Mary Kay, tell the congregation you will match whatever they give today."

The thought was so vivid that I put down the make-up I was holding and said out loud, "Wait just a minute, Lord! I've got to think this over!" Fortunately, Mel didn't hear me talking away in my dressing room. "He'll think I'm crazy!" I thought. If I even implied that God had actually spoken to me, anybody would be entitled to suggest that I need a little more rest than I'd been getting. Talking to God is one thing. Many people do that. And I'd heard of people who claim that God speaks to them, but this was the closest I'd ever come!

In the car, I had a moment to think and pray, and I was tempted to tell Mel about my idea. "Don't you dare," I repeated to myself as we rode in silence. I tried to gather my thoughts for my speech; all I could think about was that sentence which had come into my head so very clearly and so unexpectedly: "Mary Kay, tell the congregation you will match whatever they give today."

By the time we got to church, the choir was in place and the service was about to begin. We had to tiptoe down the side aisle to reach our seats. We'd hardly sat down when the pastor called me to the pulpit.

As I walked up, I realized that I still had no idea of what

I was going to say. Once again I said silently, "This is in your hands, Lord." Then I found myself talking about the years I taught Sunday school back in Houston. There I worked with four- and five-year-olds and had witnessed the value of teaching the Bible when children were young. I talked about how important it is to teach children the difference between right and wrong. And I remember quoting Proverbs: "Train up a child in the way he should go, and when he is old, he will not depart from it."

Then I heard myself saying, "You know, we've all been talking about this building for quite some time. And each Sunday we've been getting about six hundred dollars. On a good week, we might even get a thousand. But at this rate, these children are going to have grandchildren before the building is built. We must do something about this."

"You've heard me talk about our company and how we operate on a cash basis. Well, I'll match whatever you give today."

Complete silence. I took a deep breath and went on.

"You know that we operate on a no-credit basis, so I don't want pledges from you today—I want cash or checks!" And then for good measure, I repeated, "Whatever you give today, I'll match."

There, I had done it. I glanced at Mel. Because I had not spoken to him about my idea, and because Mel was retired and might not be able to afford this offer, I really couldn't do it in both our names. Still, I didn't want to hurt his feelings by just doing this in my name. Whatever the amount was—I knew that I was going to have to match it personally.

Mel looked shocked, and so did a few other people. But for the most part, the congregation just sat there. I really could see no reaction at all. As I walked back to my seat, I was already berating myself for an idea that had been a total failure. "Look at you," I thought. "You can sell cosmetics, but you can't sell God's work."

When the pastor finished his sermon, he paused and added, "I had some difficulty keeping your attention this morning. I hope it's because you were thinking of Mary Kay's offer." Then he looked over at me and said, "Mary Kay, I happen to know that a lot of our members make out their checks before coming to church, and so they may not have their checkbooks with them. Would it be all right if we gave them until five this afternoon?"

"That's fine," I said. I was surprised the pastor seemed to think the congregation would respond, but I hoped he was correct.

When five o'clock came, I found myself waiting for the telephone to ring. All afternoon I had been wondering how much had been given. But nobody called. I kept checking my watch, and the hours kept passing. With each hour, I became more discouraged. Obviously, the collection was so small that they were embarrassed to tell me about it. The later it got, the worse I felt. Usually I would talk to Mel about my worries, but this time I was just too embarrassed to mention it. I still hadn't heard a thing when it was time for us to go to bed.

It was about ten o'clock the next morning before I finally received a call from the chairman of the building committee.

"I was waiting for you to call last night," I said. "What happened?"

"Well," he said, "we had a meeting about this after church last night, and it got to be quite late."

"Oh. Was it that bad?"

"Oh, no, on the contrary. It was phenomenal."

Phenomenal? A thousand? Maybe more. Maybe \$2,000! Or even \$5,000? "What do you mean?" I asked him.

"Now, Mary Kay," he said carefully, "before I tell you the figure, I want to tell you what we were debating at our meeting."

"Yes?"

"We spent some time talking about this, and we decided that we do not want to hold you to your offer. I have been charged with the responsibility of making that absolutely clear to you. We know you didn't expect what happened, and we didn't either."

"I made the offer," I said, "and I'll stick to it."

"Now, you don't have to; I want you to know that. We would certainly understand if you didn't."

"How much?" This was beginning to sound more like five thousand dollars! Maybe ten thousand. If so, how wonderful! He still hesitated and I thought, "Maybe twenty thousand?"

Finally he spoke. "\$107,748."

I was the person who had gone to bed the previous night just praying that they had at least collected a thousand dollars. I have never in my life had such mixed feelings. That \$107,748, along with my contribution and what we already had, would be enough to start the building! I had asked God to tell me what to say, and He certainly had. It had succeeded beyond my wildest dreams.

On the other hand, my announcement came back to me very clearly: they had to give cash—and so did I—*today!*

By now the silence on my end of the line was becoming noticeable. "Are you there?" he asked.

"Yes," I sighed. My mind was working furiously. I don't leave that kind of cash in my passbook savings account. As money comes in, I invest it. But those other members came up with it and somehow, I would too. The only solution that occurred to me was to cancel my next appointment and set about arranging a bank loan.

"Now, you don't *have* to," he began again.

"I know, I know. And that's very considerate of you. But I certainly intend to keep my word. In fact, you be sure the building committee knows that it is definitely my pleasure."

I hope I sounded cordial; I'm not sure, because the mo-

ment I hung up that phone, I had my head in my hands. That was a lot of cash—about one hundred times more than I had expected to need. “Okay, Lord,” I said. “You got me into this. Now you get me out! How *am* I going to get this money?”

Then the phone rang. It was Richard.

(I must backtrack a bit at this point and explain something. Months before this event, Richard had come to me with an investment proposal. A geologist that he knew had developed a seismic technique for finding oil. Richard has investigated the procedure and had been very impressed with its potential. As a result, he had encouraged me to invest in two oil wells. I trusted his judgment and told him, “Go ahead.” From that day forward, I had never given those wells a thought.)

Richard was elated. “I’ve never seen anything like it in my life! Everything you put your hand to turns to gold.”

“What do you mean?”

“Those oil wells,” he said. “Remember? I’ve just heard that they’ve come in. Not one, but *both* of them. And both *gushers*! It’s unbelievable. Do you know what those wells are worth?”

“Tell me.” I’m sure that I’d stopped breathing, because I just had a funny feeling.

“Between the two of them,” he said, “your share this month will be more than one hundred thousand dollars.”

I can assure you, it was a very humble and grateful woman who took my contribution to the church at noon that day. The money I borrowed from the bank would be paid off by the end of the month with revenues from those oil wells!

This incident reminded me of something I learned as a little girl in Sunday school (incidentally, in a classroom not nearly as nice as those in our new children’s building). You never need to be afraid of giving for God—because He will always see to it that you get back a hundredfold. That’s what

the parable of the talents is all about. The more you give, the more you get. You can't outgive God.

But there is a sequel to my story. After such success, I was approached a few years later and asked to once again head up a major fund raising drive for the church. This time I decided to take a different tack: I organized other members and we spent six weeks getting the congregation ready for our proposal. One marvelous Sunday morning, we acquired pledges of over *\$10 million* for the Christian Learning Center and at another time *\$7 million* for the church sanctuary! I've said it before, but now I'll say it even stronger—you can't outgive God!

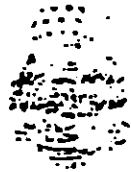

LEGISLATIVE REPORT

August 1991

First Senatorial District

Dear Friends,

On May 17 the first regular session of the 86th Missouri General Assembly came to an end. More than 1,300 bills were introduced in the Senate and House. Of these, less than 160 were passed by both chambers and sent to the governor.

The Legislature debated such diverse issues as insurance reform, the state's education system, tougher drunken driving laws, riverboat gambling, and confronted one of the ultimate questions of life -- the "right to die."

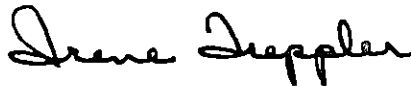
Lawmakers had a special challenge this year in preparing the state's Fiscal 1992 budget. With little revenue growth and increasingly needy state programs, we were faced with some tough decisions. We tried to make cuts where they would hurt the least and where the fewest number of citizens would feel the pinch.

The purpose of this newsletter is to supply you with information on some of the bills we passed and how they affect you.

I also would like to ask your help in setting my 1992 legislative agenda. I need to know what you think the most important issues facing the state are and how you think we should address them. Please do not hesitate to call or write to express your views.

I find it a great honor to serve you in the Missouri Senate and hope you may be able to visit next session to see your Legislature at work.

◆ A Safer Missouri -- Tighter DWI Laws

Missouri is strengthening criminal and administrative drunken driving laws. Several changes in current state law were made in the recent legislative session to bring Missouri into compliance with federal law and to protect the state's eligibility for federal grant money.

The Blood Alcohol Content (BAC) rate for an administrative suspension or revocation will be lowered from 0.13 to 0.10 of 1 percent. Restricted driving privileges could only be granted after the person has had his or her driver's

license suspended for 30 days.

No hardship licenses will be granted by a court until the offender has completed 30 days of a suspension or a year of revocation.

A person who refuses to submit to a BAC test at the time of arrest will have his or her driver's license revoked for one year. Hardship licenses will not be granted until 90 days of revocation have been completed.

Also under this measure, certain municipal DWI violations will have the same penalties as state violations.

Currently, municipal DWI violations do not become a part of a person's driving record. This measure will make all DWI violations part of the record to avoid allowing someone with prior offenses being treated as a first-time offender.

For years, legislators have been working on passing an "open container" law in Missouri. This measure now makes it illegal to drink an alcoholic beverage while operating a motor vehicle.

Changes are also made in the "Abuse and Lose" law.

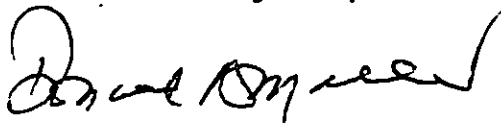

Nation Called to 40 Days of Prayer

A challenge has gone out to church leaders and government officials, prayer leaders and all citizens of the United States to join in the observance of a *National 40 Days of Prayer* from September 25 through November 3, 1992.

"The times demand it! This is an election year! We must have divine guidance! Prayer is crucial! Our problems are insurmountable!" says Ray Bringham, the national coordinator. He adds that "joblessness, homelessness, hunger, drugs, AIDS, gangs, violence and crime abound. Discouragement, despondency and hopelessness prevail." Bringham and other Christian leaders believe that our nation is at a crossroads and a time of crisis.

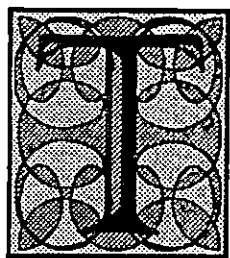
Richard C. Halverson, Chaplain of the United States Senate says "...the roots of our greatness as a nation are spiritual and moral. The greatest threat to our civilization is secularization, which has eliminated the spiritual from serious discussion and precipitated epidemic moral decline which exceeds the best and finest efforts of the most powerful. Nothing is clearer than that God alone is able to rescue our decaying society: Nothing is clearer than that He waits for His people to reject materialism as a way of life: and that the crisis requires repentance from worldly wayward-

ness and devotion to prayer."

Bringham started the *National 40 Days of Prayer* because he believes that "the crisis we face now demands both extraordinary prayer and drastic action. The whole body of Christ must be challenged to turn to God in deep repentance and total dependence on Him to save our nation." "Prayer must be our priority," he adds.

A coalition of prayer leaders across America and in the greater St. Louis area have responded to Rev. Bringham's challenge. Rolland C. Smith of Mission Omega is chairman of the St. Louis coalition which includes Christians from all parts of the body of Christ. Smith suggests that St. Louisans can join in the *National 40 Days of Prayer* in many different ways, such as setting aside personal times of prayer and fasting, planning a 24 hour prayer watch with friends, or organizing a prayer rally at churches or with individual prayer groups. The St. Louis Coalition will also be planning an area wide corporate prayer gathering on November 1.
