SUBJECT: Cancellation of Nakasone Call on President

Japanese Embassy called this morning, with deep regret, to cancel the scheduled call on the President by former Prime Minister Yasuhiro Nakasone. The call had been approved for March 10, at 3:15PM.

Nakasone is cancelling his entire U.S. trip, and this clearly shows the spreading impact of the "Recruit" scandal in Japan.
